Code of Conduct for Social Auditors

At the heart of Social Audit lies a robust code of conduct, underpinning integrity, confidentiality, objectivity, independence, and professional acumen. Certification requirements serve as gatekeepers, ensuring auditors possess the requisite expertise to navigate social responsibility assessments effectively.

Becoming a certified social auditor requires meeting specific qualifications and undergoing rigorous training. Key certification requirements include:

- Post-Graduates:** Individuals with post-graduate degrees from UGC-recognized universities and a minimum of 3 years of experience in the development sector are eligible for certification.
- Graduates:** Graduates from UGC-recognized universities with at least 6 years of experience

in the development sector can also qualify.

- 3. Accredited Professionals:** Chartered Accountants (CAs), Company Secretaries (CSs) and Certified Management Accountants (CMAs) or individuals with suitable accreditations, along with a minimum of 6 years of experience in the development sector, are eligible.
- 4. NISM Certificate Course:** Completion of the NISM certificate course and successful clearance of the Social Auditors Certification Examination are essential steps towards certification under the Institute of Social Auditors of India (SRO).

Empanelment of Social Auditors with SROs

The era of new India

'Ye Naya Hindustan Hai, Ghar Mein Ghusega Bhi Aur Marega Bhi...' This dialogue from the movie Uri applies to all sectors of India, not just the economy. The government led by Prime Minister Narendra Modi is proving that the majority government can create miracles. It will not be an exaggeration to say that this government has made efforts for the dawn of a new India when it comes to the economic sector. The picture/blueprint new India can be seen in the budgets presented from 2014 to 2023.

Finance Minister Arun Jaitley played an important role in Prime Minister Modi's cabinet. In 2014, Prime Minister Narendra Modi's government had reset and align things in various sectors. The first general budget of 2014-15 under the Modi government made several announcements related to the health sector. Meanwhile, emphasis was placed on the establishment of medical educational institutions in the country. The Finance Minister encouraged large scale solar power projects. A plan was made to set

up 'Namami Gange Project' under the Integrated Ganga Conservation Mission. A provision of Rs 2,037 crore was made for this in the budget. In the subsequent budget i.e. in 2015, emphasis was placed on preventing tax evasion/ tax theft. Rules were tightened to prevent tax evasion. Cash transactions in rupees were limited during this period. Along with this, approval was given to start new IITs and AIIMs in the country. Also, many steps were taken to strengthen the energy structure of the country seeing the future needs. A target to double farmers' income by 2022 was set. Accordingly, in 2016, Arun Jaitley presented the general budget for the third time in the Modi government. For cleanliness in rural parts of country, the Center emphasized the Swachh Bharat Abhiyan. A provision of Rs.9 thousand crores was made for it. One of the far-reaching and ambitious promises made by the Finance Minister was to double farmers' income by 2022. The year 2017 was important in terms of budget. This year, both the general budget and the railway budget were

presented together. The tradition of presenting railway budget separately was canceled from 2017. In the same year, Arun Jaitley presented the general budget of the Narendra Modi government for the fourth time. Demonetization was conducted in the country three months before the Budget. Therefore, the whole country was hoping relief from budget of 2017. In 2017-18, the Railway Budget was merged with the General Budget. Income tax rate were cut by 5 percent for individuals earning between Rs 2.5 lakh and Rs 5 lakh. No change was made in the tax slab to provide relief from demonetization and to double farmers' income. In 2018, Arun Jaitley presented the budget for the fifth time. 2018-19 was a step towards India's growth rate to be over 8 percent. Presenting the 2018-19 General Budget in Parliament, the then Finance Minister Arun Jaitley said, 'Indian society, politics and economy have shown remarkable resilience in adapting to structural reforms like GST and demonetization. Before presenting the interim budget for 2019-20, Finance Minister Arun Jaitley was diagnosed with cancer. Therefore, Finance Minister Piyush Goyal presented the interim budget for 2019-20 in the House before the general elections. So in the budget presented in the Parliament on February 1, 2019, a big scheme was introduced for farmers and income tax relief was announced. In 2019, Nirmala Sitharaman became the country's second woman finance minister after returning to the central government under the leadership of Narendra Modi. She presented the budget for 2019-20 for the first time in July. Meanwhile, it was decided to levy a surcharge of 3 percent on

those earning Rs 2-5 crore and 7 percent on those earning more than Rs 5 crore. Meanwhile, several steps were taken for electric vehicles and affordable housing. A target of improvement of 1.25 lakh km of roads was set at a cost of over Rs 80,000 crore in the next five years. Many changes were made in the civil aviation sector of the country. The policy of leasing the airport was approved. To promote the Make in India objective, it was decided to increase basic customs duty on certain goods. Imports of defense equipment not manufactured in India are exempted from basic customs duty. The government increased the custom duty on gold. Presenting the second budget in 2020, Sitharaman raised taxes on petrol and diesel, raised import duty on gold, imposed an additional surcharge on the super-rich and introduced a tax on high-value cash withdrawals. She tried to speed up development by lowering corporate taxes and providing incentives for housing. Several steps were taken to promote startups and electric vehicles. In 2021, Nirmala Sitharaman presented the general budget for the third time. It focused on India's inclusive growth. Several direct tax reforms like income tax exemption for senior citizens aged 75 years and above, National Center for Faceless Income Tax Appellate Tribunal, pre-filing of returns, advance tax on dividend income etc were proposed. In Budget 2022, Sitharaman aimed to take forward India's aspirations in the 'Amrit Kaal' as it moves towards the 100th year of independence. Focus was made on public capital investment to encourage private investment in areas such as technology-enabled development, energy and climate

change. In Budget 2023, emphasis was placed on economic empowerment of women, clarifying Amritkal's vision. PM Vishwakarma Kaushal Samman Scheme was introduced. 1) Inclusive development, 2) Reaching every nook and cranny of the country, 3) Infrastructure and investment, 4) Opportunities for talent, 5) Green develop-

ment, 6) Youth power, 7) Economic sector became the major features of the Saptarishi budget. Considering the last 75 years, the budget presented by the government under the leadership of Prime Minister Modi became a 'vision document' providing a vision towards India's future self-reliance, not just limited to economic reforms.
