

What is Data? A piece of information (i.e., in common terms) “Facts and statistics collected together for reference or analysis.” It is a base from which we derive the information to draw conclusions. **Clive Humby** quoted “**Data is the new oil**”. He is a British mathematician also an entrepreneur in the field of **data science** and **customer-**

centric business strategies who established **Tesco’s Clubcard loyalty program** which we are all part of nowadays. For illustration when we visit a mall or big brands, we are offered a card that holds points for every purchase we make from them and later which are redeemable in future.

Now let’s have a light on ‘**Analysis**’ and ‘**Analytics**’. The term ‘**Analysis**’ means a detailed **examination of the elements or structure** of something. An analysis looks backwards over time, providing marketers with a historical view of what has happened Whereas ‘**Analytics**’ means systemic computational analysis of data or statistics. It is used for the discovery, interpretation, and communication of meaningful patterns in data. Analytics look forward to modelling the future or predict a result. At this point let’s


combine Data & Analysis. Data Analysis is a “Process of inspecting, cleansing, transforming and modelling data to discover useful information, informing conclusions and supporting decision-making” In today's business world, data analysis plays a role in making decisions more scientific and helping businesses operate more effectively.

Let's check the Tools for Data Analysis

Excel: It has a variety of compelling features, and with additional plugins installed, it **can handle a massive amount of data**. So, if you have data that does not come near the significant data margin, then Excel can be a very versatile tool for data analysis.



Tableau: It falls under the BI Tool category, made for the **sole purpose of data analysis**. The essence of Tableau is the Pivot Table and Pivot Chart and works towards representing



data in the most user-friendly way. It additionally has a data cleaning feature along with brilliant analytical functions.

Power BI: It initially started as a plugin for Excel, but later on, detached from it to develop in one of the most data analytics tools. Its PowerPivot and DAX language **can implement sophisticated advanced analytics** similar to writing Excel formulas.



Fine Report: comes with a straightforward drag and drops operation, which helps to design various styles of reports and build a



data decision analysis system. It can directly connect to all kinds of databases, and its format is similar to that of Excel. Additionally, it also **provides** a variety of dashboard templates and **several self-developed visual plug-in libraries**.

R & Python: These are programming languages that are **very powerful and flexible**. **R** is best at statistical analysis, such



as normal distribution, cluster **classification algorithms**, and **regression analysis**. It also **performs** individual **predictive analysis** like **customer behaviour**, his **spending**, items preferred by him **based on his browsing history**, and more. It also involves concepts of machine learning and artificial intelligence.

After having a look at the tools, now how should we decide to pick the right tool? Given below are certain key factors which must be fulfilled by the Software/Tool.

The right Data Analytic software will also hold these capabilities:

- Log procedures performed on data.
- Allow users to easily re-run the analysis with minor changes.
- Be scalable with regards to the platform.
- Ensure that the vendor's vision is in line with the organization's vision.

Now let's understand some Data Analysis

Applications for Internal Audit:

Data analysis is useful for tracing Improper Disbursements like Duplicate Payments, Unapproved Purchases, Payments for items not received, Payments in excess of approval levels, Missed discounts or credits. Explaining them further data analysis helps in the following:

- Detect duplicate payments using dates, payees, vendor invoice numbers and amounts.
- Identify invoices or payments to vendors without a valid purchase order.
- Find invoices for more than one purchase order authorization.
- Extract vendors with duplicate invoice numbers.
- Find invoice payments issued on non-business days (Saturdays and Sundays).
- Identify credits issued by or outstanding with vendors.
- Identify goods invoiced and paid, but not shown as being received
- Look for payments to vendors not on contract.
- Look for multiple payments to the same vendor on the same date or the same amount (excluding recurring charges, such as rent).

Moving ahead to talk about Data Analysis Techniques. There are different techniques for Data Analysis depending upon the question at hand. To classify them there are two techniques **based on Mathematics and**

Statistics another **based on Visualization and Graphs.**

Now talking about Techniques based on **Mathematics and Statistics** here are some of them:

- **Descriptive Analysis:** Descriptive Analysis takes into account the historical data, Key Performance Indicators, and describes the performance based on a chosen benchmark. It takes into account past trends and how they might influence future performance.
- **Factor Analysis:** A technique that is used to reduce a large number of variables into a fewer number of factors. This technique extracts maximum common variance from all variables and puts them into a common score. As an index of all variables, we can use this score for further analysis.
- **Regression Analysis:** This technique works by *modelling the relationship between a dependent variable and one or more independent variables* (often called 'predictors', 'covariates', or 'features'). The most **common form** of regression analysis is **linear regression**. Regression can help finance and investment professionals as well as professionals in other businesses. Regression can **also help predict sales** for a company **based on weather, previous sales, GDP growth**, or other types of conditions.
- **Discriminant Analysis:** It is a classification technique in data mining. It identifies the different points in different groups based on variable

measurements. In simple terms, it identifies what ***makes two groups different from one another***; this helps to identify new items.

- **Time Series Analysis:** In this kind of analysis, measurements are spanned across time, which gives us a collection of organized data known as time series.

Moving ahead towards Techniques based on **Visualization and Graphs**

- **Column Chart, Bar Chart:** Both these charts are used to present numerical differences between categories. The column chart takes to the height of the columns to reflect the differences. Axes interchange in the case of the bar chart.
- **Funnel Chart:** This chart represents the proportion of each stage and reflects the size of each module. It ***helps in comparing rankings.***
- **Line Chart:** This chart is used to represent the change of data over ***a continuous interval of time.*** It is the

most commonly used nowadays at every instance.

- **Area Chart:** This concept is based on the line chart. It additionally fills the area between the polyline and the axis with colour, thus representing better trend information.

Well even after understanding data analysis, various tools and methods of analysis there are few things to be kept under a view of certain standards on internal audit. Before moving on to those, let us know, what are Standards on Internal Audit? They are Standards on Internal Audit (SIAs) establish uniform evaluation criteria, methods, processes and practices. The Standards are pronouncements that form the basis for conducting all internal audit activity. These pronouncements are designed to help the internal auditor to discharge his responsibilities was, originally, issued in November 2004, revised in July 2007, and was recommendatory in nature. and

Standards on Internal Audit shall become mandatory from such date as notified by the Council.

I would like to mention a few to conclude, they are **SIA 7 – Quality Assurance in Internal Audit** which specifies a system for assuring quality in an internal audit. There should be a reasonable assurance that the internal auditors comply with professional standards, regulatory and legal requirements so that the reports issued by them are appropriate in the circumstances. Also, **SIA 14 - Internal Audit**

in an Information Technology Environment which ensures that authorized, correct and complete data is made available and provides for timely detection and correction of errors; accuracy and completeness of output; provide adequate data security; prevent unauthorized amendments; provide for the safe custody of source code of application software and data files.

Hope this information is enlightening and useful to the dear reader
